- 1 **Cooling**
 - PHF/TCS* food cooled from 135°F to 70°F more than 2 hours OR 135°F to 41°F (45°F) more than 6 hours; OR prepared food cooled to 41°F (45°F) more than 4 hours:
Action: Voluntary destruction, rapid reheating of cooked foods if less than 4 hours

- 2 **Cold Hold**
 - PHF/TCS food held above 41°F (45°F) more than 4 hours:
Action: Voluntary destruction

 - PHF/TCS food held above 41°F (45°F) less than 4 hours:
Action: Rapid cool (e.g. ice bath)

- 3 **Hot Hold**
 - PHF/TCS food held below 135°F more than 4 hours:
Action: Voluntary destruction

 - PHF/TCS food held below 135°F less than 4 hours:
Action: Rapid reheat to 165°F or more

- 4 **Cooking**
 - PHF/TCS food undercooked:
Action: Re-cook to proper temperature

- 5 **Rapid Reheating**
 - Cold PHF/TCS food improperly reheated:
Action: Reheat rapidly to 165°F

- 7 **Handwashing**
 - Food employees observed not washing hands:
Action: Instruct employees to wash hands as specified in the Rules

- 9, 10 **Approved Source/Sound Condition**
 - Foods from unapproved sources/unsound condition:
Action: Voluntary destruction

- 11 **Proper Handling of Ready-to-Eat Foods**
 - Employee did not properly wash and sanitize hands before touching ready-to-eat food with bare hands:
Action: Voluntary destruction

- 12 **Cross-Contamination of Raw/Cooked Foods**
 - Ready-To-Eat food contaminated by raw PHF/TCS food:
Action: Voluntary destruction of ready-to-eat foods

- 14 **Water Supply**
 - Facility does not have water for washing hands, preparing food, or cleaning equipment/utensils:
Action: Voluntary suspension of food preparation
